Special Feature of Vacation Protector

Pre-Existing Conditions Exclusion and Waiver

This program does not cover losses or expenses if they result from any injury occurring prior to and including the effective date of this insurance and any illness occurring during the 120 days prior to and including the effective date of your insurance for which: a) medical diagnosis or treatment by a Physician has been sought or advised or for which symptoms exist which would cause a prudent person to seek diagnosis, care or treatment; or b) require taking prescribed drugs or medicine unless the illness remains controlled without any change in the required prescription. Coverage for a Pre-existing Medical Condition is excluded unless: You purchased your plan within 21 days of making your first trip payment or first trip deposit; You purchased trip cancellation coverage that covers the full cost of all your non-refundable trip arrangements; You were a U.S. resident and medically able to travel on the day you purchased the plan; and the total cost of your trip is \$10,000 per person or less.



Access America will refund your insurance premium if you cancel your insurance within 10 days of purchase and have not filed a claim or departed on your trip. This is a brief description of the insurance and assistance benefits provided by this plan. Exclusions, conditions and limitations may apply. S Trip Cost Protection

Trip Cancellation Coverage. Derived Reimburses your prepaid, non-refundable expenses if you must cancel your trip due to a covered reason.


